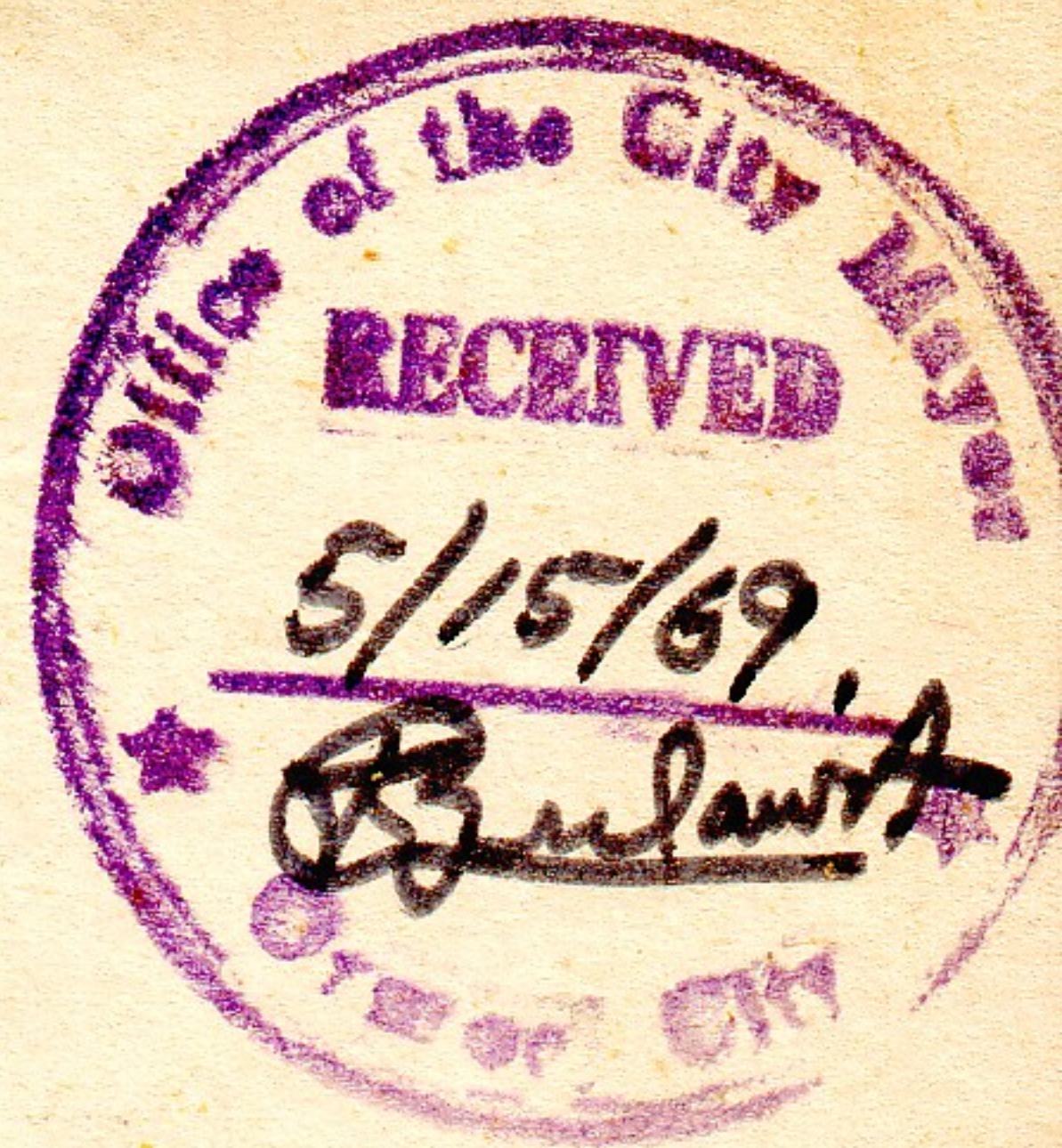

RESOLUTION NO. 68

"WHEREAS, His Honor, the Mayor, this City, has today referred to this august Body for consideration and appropriate action the communication of the Honorable Majority Floor Leader, House of Representatives, Manila, which is quoted hereunder, verbatim, to wit:

'March 27, 1969

'Mayor Iñaki Larrazabal
Ormoc City

'Dear Mayor Larrazabal:

'This is in connection with your request that Acting City Fiscal Redubla's designation be made in accordance with the provision of Commonwealth Act Number 9588.

'The position of City Fiscal of Ormoc is not vacant, hence, he cannot be appointed City Fiscal. The Municipal Board of Ormoc can neither appropriate the amount of P900 as the City's counterpart of the salary of Assistant Provincial Fiscal Redubla in his capacity as Acting City Fiscal of Ormoc because this is never allowed by law, according to the Department. However, the Board may appropriate the amount as his representation allowance which shall not exceed P150 a month.

"NOW, THEREFORE, on motion of Councilor Kangleon, jointly seconded by Councilors Aviles and Porcadilla:

"RESOLVED, to adopt:

ORDINANCE NO. 30

AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND EIGHT HUNDRED PESOS (P1,800.00) FROM SALARY SAVINGS OF THE LAW DEPARTMENT FOR REPRESENTATION ALLOWANCE OF THE ACTING CITY FISCAL FOR THE CURRENT FISCAL YEAR AT THE RATE OF ONE HUNDRED FIFTY PESOS (P150.00) PER MONTH.

BE IT ORDAINED, by the Municipal Boar of Ormoc City,
That:

SECTION 1. The sum of one thousand eight hundred pesos (P1,800.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings of the Law Department, said sum to be made available as supplemental appropriation for representation allowance of the Acting City Fiscal for the current fiscal year at the rate of one hundred fifty pesos (P150.00) per month.

SECTION 2. This Ordinance shall take effect immediately upon its approval.



"CARRIED UNANIMOUSLY."


