ORDINANCE NO. 32

AN ORDINANCE REVERTING \$3,600.00 FROM OUT OF SALARY SAVINGS OF THE MUNI-CIPAL BOARD TO COVER SIX-MONTH-SALARY GRANT OF COMPENSATION TO THE SURVIVING SPOUSE AND MINOR LEGITIMATE CHILDREN OF THE LATE CITY COUNCILOR JOSE GARCES NAVARRO IN ACCORDANCE WITH R.A. NO. 779.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of three thousand six hundred pesos (#3,600.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings of the Municipal Board, said sum to be made available as supplemental appropriation to cover six-month-salary grant of compensation to the surviving spouse and minor legitimate children of the Late Councilor Jose Garces Navarro, in accordance with Republic Act No. 779.
