

RESOLUTION NO. 80

"WHEREAS, the Deputy Chief of Police in his communication dated April 28, 1969, had, among other things, requested an appropriation of one hundred five pesos (#105,00) for registration fees, diplomas and other incidental expenses of the five members of the Ormoc City Police Department, namely: Cpl. Cipriano Natividad, Patrolmen Juanito Braca, Maximo Lauron, Medardo Magdadaro and Benedicto Espere, in attending the seminar on trade unionism conducted by the Asian Labor Education Center of the University of the Philippines conducted in the City of Ormoc from April 21 to May 3, 1969, inclusive, at the rate of twenty-one pesos (P21.00) per member;

"WHEREAS, upon verification of the records it has been found out that the attendance of the five members of the Ormoc City Police Department has been approved by His Honor, the Mayor of Ormoc City;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by Councilor Porcadilla;

"RESOLVED, to consider the request of the Deputy Chief of Police and do, as this Body hereby does, adopt:

ORDINANCE NO. 33

ORDINANCE REVERTING THE SUM OF ONE HUNDRED FIVE PESOS (\$105.00) FROM OUT OF SALARY SAVINGS OF THE ORMOC CITY POLICE DEPARTMENT TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR REGISTRATION FEES, DIPLOMAS AND OTHER INCIDENTAL EXPENSES INCURRED BY THE FIVE MEMBERS OF THE SAID DEPARTMENT IN CONNECTION WITH THE SEMINAR ON TRADE UNIONISM CONDUCTED BY THE U.P. ASIAN LABOR EDUCATION CENTER IN THE CITY OF ORMOC FROM APRIL 21 TO MAY 3, 1969. INCLUSIVE.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one hundred five pesos (F105.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings of the Ormoc City Police Department, said sum to be made available as supplemental appropriation for registration fees,

diplomas and other incidental expenses incurred by the five members of the Ormoc City Police Department attending the seminar on trade unionism conducted by the Asian Labor Education Center of the University of the Philippines in the City of Ormoc from April 21 to May 3, 1969, inclusive, at the rate of twenty-one pesos (#21.00) per member.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, May 21, 1969.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the Deputy Chief of Police, the City Treasurer and the City Auditor, all of Ormoc City;
