RESOLUTION NO. 92

"WHEREAS, the City Health Officer in a letter dated June 17, 1969, has requested the reversion of P367.47 from out of unexpended balances in his department to be made available for payment of its outstanding obligation;

"NOW, THEREFORE, on motion of Councilor Kangleon, jointly seconded by the Floor Leader, Councilors Aviles and Samson;

"RESOLVED, to approve the request of the City Health Officer and do, as this Body hereby does, adopt:

ORDINANCE NO. 34

AN ORDINANCE REVERTING THE SUM OF THREE HUNDRED SIXTY-SEVEN PESOS AND FORTY-SEVEN CENTAVOS (P367.47) FROM ANY SAVINGS IN THE CITY HEALTH DEPARTMENT TO BE MADE AVAILABLE FOR PAYMENT OF ITS OUTSTANDING OBLIGATIONS.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of three hundred sixty-seven pesos and forty-seven centavos (P367.47), or so much thereof as may be necessary, is hereby reverted from out of any savings in the City Health Department said sum to be made available as supplemental appropriation for payment of its outstanding obligations.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
