RESOLUTION NO. 93

"WHEREAS, Atty. Ramon E. Solis, Jr., the new City Fiscal, in a letter dated June 16, 1969, has informed this august Body that he took his oath and assumed office on May 28, 1969, at Manila where he attended the convention of the Government Prosecutors League of the Philippines in his official capacity as such City Fiscal of Ormoc for which he incurred actual and necessary travel and transportation expenses amounting to ₱443.00, and that on June 2, 1969, he received Circular No. 48 from the Secretary of Justice enjoining all members of the Government Prosecutors League to attend an important conference in Manila whereby he will incur another expenses of not less than ₱350.00, so much so that he has requested the reversion of sufficient sum from salary savings in his department to cover reimbursement of his previous expenses and for cash advance in connection with his attending the conventions of the league;

"NOW, THEREFORE, on motion of Councilor Porcadilla, jointly seconded by Councilors Kangleon and Aviles;

"RESOLVED, to consider the request of the City Fiscal and do, as this Body hereby does, adopt:

ORDINANCE NO. 35

AN ORDINANCE REVERTING THE SUM OF EIGHT HUNDRED PESOS (₱800) FROM SALARY SAVINGS IN THE LAW DEPARTMENT TO BE MADE AVAILABLE FOR TRAVEL AND TRANSPORTATION OF THE CITY FISCAL

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of eight hundred pesos (₱800.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings in the Law Department said sum to be made available as supplemental appropriation for travel and transportation of the City Fiscal.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
