RESOLUTION NO. 102

"WHEREAS, the City Treasurer in his letter dated July 16, 1969, has informed this august Body that upon verification of the approved city budget for the current fiscal year it was noted that there is no appropriation for the city's share of election expenses in connection with this year's special election for one city councilor, so that he has requested an appropriation of P5,000.00 for the purpose, otherwise our budget will be returned unacted by the Secretary of Finance;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by Councilor Aviles;

"RESOLVED, to adopt:

ORDINANCE NO. 38

AN ORDINANCE PROVIDING FIVE THOUSAND PESOS (P5,000.00) AS SUPPLEMENTAL APPROPRIATION FOR THE CITY'S SHARE OF ELECTION EXPENSES IN CONNECTION WITH THIS YEAR'S SPECIAL ELECTION FOR ONE CITY COUNCILOR.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Five Thousand Pesos (P5,000.00), or so much thereof as may be necessary, is hereby appropriated in the manner provided hereunder as follows:

- a) From funds not otherwise appropriated ..... P1,000.00  
b) Reversion from Item No. 28 (Improvement projects)  
of (C-35) Ormoc City Waterworks System ..... 4,000.00  
Total ..... P5,000.00

said sum to be made available as supplemental appropriation for the city's share of election expenses in connection with this year's special election for one city councilor.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, July 16, 1969.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the Honorable Secretary of Finance and the Honorable Commission on Elections, both of Manila; the Waterworks Supervisor, the City Election Registrar, the City Treasurer and the City Auditor, all of Ormoc City;
