ORDINANCE NO. 38

AN ORDINANCE PROVIDING FIVE THOUSAND PESOS (P5.000.00) AS SUPPLEMEN-TAL APPROPRIATION FOR THE CITY'S SHARE OF ELECTION EXPENSES IN CONNECTION WITH THIS YEAR'S SPECIAL ELECTION FOR ONE CITY COUNCILOR.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Five Thousand Pesos (#5,000,00), or so much thereof as may be necessary, is hereby appropriated in the manner provided hereunder as follows:

a) From funds not otherwise appropriated Pl,000.00

b) Reversion from Item No. 28 (Improvement projects)

of (C-35) Ormoc City Waterworks System 4.000.00 Total #5,000.00

said sum to be made available as supplemental appropriation for the city's share of election expenses in connection with this year's special election for one city councilor.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
