



EXCERPT FROM THE MINUTES OF THE REGULAR SESSION OF THE

RESOLUTION NO. 104

"WHEREAS, the Principal of the Ormoc City High School has reported that there has been a decline in the enrolment of students this year to only 800 as compared to last year's 1,200 students which would greatly deplete the income of the said institution to the prejudice of its operation and maintenance;

"WHEREAS, to lessen the burden of the Ormoc City High School, especially in matters of salaries and wages of its personnel, the Committee on Education has recommended that the position of one janitor-watchman be abolished inasmuch as the said position could be readily handled by either the other janitor or the laborer;

"NOW, THEREFORE, on motion of Councilor Porcadilla, jointly seconded by Councilors Aviles and Samson;

"RESOLVED, to adopt:

ORDINANCE NO. 39

AN ORDINANCE ABOLISHING THE POSITION OF ONE JANITOR-WATCHMAN IN THE ORMOC CITY HIGH SCHOOL FOR REASONS OF ECONOMY

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The position of one (1) Janitor-Watchman in Item No. 9 under (D-21) Ormoc City High School is hereby abolished for reasons of economy.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
