ORDINANCE NO. 40

AN ORDINANCE REVERTING THE SUM OF THREE HUNDRED PESOS (#300,00) FROM TIEM NO. 25 (DENTAL SUPPLIES) OF (C-17) HEALTH DEPARTMENT, 1969-1970 ORMOC CITY BUDGET, TO BE MADE AVAILABLE AS SUPPLEMENTAL AP-PROPRIATIONS FOR THE PURCHASE OF NECESSARY EQUIPMENT AND MATERIALS AND REPAIR OF THE DENTAL UNIT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of three hundred pesos (\$300.00), or so much thereof as may be necessary, is hereby reverted from Item No. 25 (Dental supplies) of (C-17) Health Department, page 15, 1969-1970 Ormoc City Budget, said sum to be made available as supplemental appropriations for the purchase of necessary equipment and materials and repair of the Dental Unit.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
