RESOLUTION NO. 107

"WHEREAS, the City Health Officer in his communication dated July 29, 1969, has recommended favorable consideration of the request of the City Dentist for the reversion of P300.00 from Item No. 25 (Dental supplies) of the Health Department in the 1969-1970 City Budget to be made available for appropriation for the repair of the dental unit and purchase of necessary equipment and materials;

"NOW, THEREFORE, on motion of Councilor Kangleon, jointly seconded by Councilors Samson and Porcadilla;

"RESOLVED, to adopt:

ORDINANCE NO. 40

AN ORDINANCE REVERTING THE SUM OF THREE HUNDRED PESOS (P300.00) FROM ITEM NO. 25 (DENTAL SUPPLIES) OF (C-17) HEALTH DEPARTMENT, 1969-1970 ORMOC CITY BUDGET, TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATIONS FOR THE PURCHASE OF NECESSARY EQUIPMENT AND MATERIALS AND REPAIR OF THE DENTAL UNIT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of three hundred pesos (P300.00), or so much thereof as may be necessary, is hereby reverted from Item No. 25 (Dental supplies) of (C-17) Health Department, page 15, 1969-1970 Ormoc City Budget, said sum to be made available as supplemental appropriations for the purchase of necessary equipment and materials and repair of the Dental Unit.

SECTION 2. This Ordinance shall take effect immediately upon its approval.






