"RESOLVED, to adopt:

ORDINANCE NO. 44

AN ORDINANCE MAENDING ORDINANCE NO. 41, CURRENT SERIES, AS "AN ORDINANCE REQUIRING ALL HOSTESSES TO SUBMIT TO THE CITY HEALTH DEPARTMENT FOR QUARTERLY PHYSICAL AND MEDICAL EXAMINATION AND WEEKLY LABORATORY EXAMINATION, PRESCRIBING FEES THEREFOR, PROVIDING PENALTIES FOR VIOLATION THEREOF, AND FOR OTHER PURPOSE".

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The title of Ordinance No. 41, current series, is hereby amended to read as follows:

"AN ORDINANCE REQUIRING ALL HOSTESSES TO SUBMIT TO THE CITY HEALTH DEPARTMENT FOR QUARTERLY PHYSICAL AND MEDICAL EXAMINATIONS AND WEEKLY LABORATORY EXAMINATIONS, PRESCRIBING FEES THEREFOR, PROVIDING PENALTIES FOR VIOLATIONS THEREOF, AND FOR OTHER PURPOSES".

SECTION 2. Section 2 of Ordinance No. 41, current series, is hereby amended to read as follows:

"SECTION 2. Quarterly physical and Medical examination and weekly laboratory examinations. All hostesses subject of this Ordinance shall submit themselves for physical and medical examinations every quarter and for laboratory examinations every week at the City Health Department: PROVIDED HOWEVER, That such examinations shall be conducted by any competent physician under the direct supervision of the City Health Officer."

SECTION 3. Section 3 of Ordinance No. 41, current series, is hereby amended to read as follows:

"SECTION 3. Fees. - Subsequent to the requirements imposed in Section 2 hereof, there shall be paid to the City Treasurer by every hostess the sum of five pesos (P5.00) for every quarterly physical and medical examinations for which a medical certificate shall be issued by the City Health Officer. Certificates of laboratory examinations shall be issued weekly free of charge."

SECTION 4. This Ordinance shall take effect immediately upon its approval.

ENACTED, September 10, 1969.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the City Judge, the City Fiscal, The City Treasurer, the City Auditor, The City Health Officer, and all operators, owners or managers of clubs, bars, cocktail lounges or the like, of Ormoc City;
