RESOLUTION NO. 127

"WHEREAS, Memorandum Circular No. 138 of the Office of the President of the Philippines dated December 15, 1967, prescribing the policy regarding the grant of representation allowances to certain local government officials, has been amended by Memorandum Circular No. 255 of the same Office dated April 23, 1969, so as to include Provincial Board and City Board/Council Secretaries among the officials entitled to representation allowances provided that the rates for those in Third and Fourth Class Provinces and Cities, among others, shall be one hundred fifty pesos (P150.00) each per month;

"WHEREAS, this august Body understands well the plight of the Secretary to the Board who, as an alter-ego of the city law-making body, is always and ever swarmed with guests in his office mostly barrio officials, barrio school officials and even city officials and sometimes our constituents from various walks of life making representations with this Board through him in quest for action of the Board on their requests, verbal or written, and all other pertinent matters relative to the official functions of the Municipal Board which the Secretary immediately attends to for the good of the service;

"WHEREAS, our Secretary, in the name of this Board, sometimes has to spend his own money to entertain these guests and at times has to resort to borrowing in order that he could serve the guests for and in behalf of the Municipal Board;

"WHEREAS, it is about time to relieve our Secretary of this financial handicap by way of implementing in his favor Memorandum Circular No. 255 of the Office of the President of the Philippines dated April 23, 1969, in order that he could further entertain guests without so much drain in his pocketbook;

"NOW, THEREFORE, on motion of Councilor Kangleon, jointly seconded by Councilors Tan and Porcadilla;

"RESOLVED, to adopt:

ORDINANCE NO. 45

AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND EIGHT HUNDRED PESOS (P1,800.00) FROM OUT OF SAVINGS IN THE MUNICIPAL BOARD TO BE MADE AVAILABLE FOR SUPPLEMENTAL APPROPRIATION FOR MONTHLY REPRESENTATION ALLOWANCES OF THE SECRETARY TO THE BOARD IN ACCORDANCE WITH MEMORANDUM CIRCULAR NO. 255 OF THE OFFICE OF THE PRESIDENT OF THE PHILIPPINES DATED APRIL 23, 1969.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one thousand eight hundred pesos (P1,800.00), or so much thereof as may be necessary, is hereby reverted from out of savings of the Municipal Board in the current appropriations said sum to be made available for supplemental appropriation for the monthly representation allowances of the Secretary to the Board in accordance with Memorandum Circular No. 255 of the Office of the President of the Philippines dated April 23, 1969: PROVIDED, HOWEVER, that sufficient fund for this purpose shall be appropriated in subsequent general appropriation ordinances.

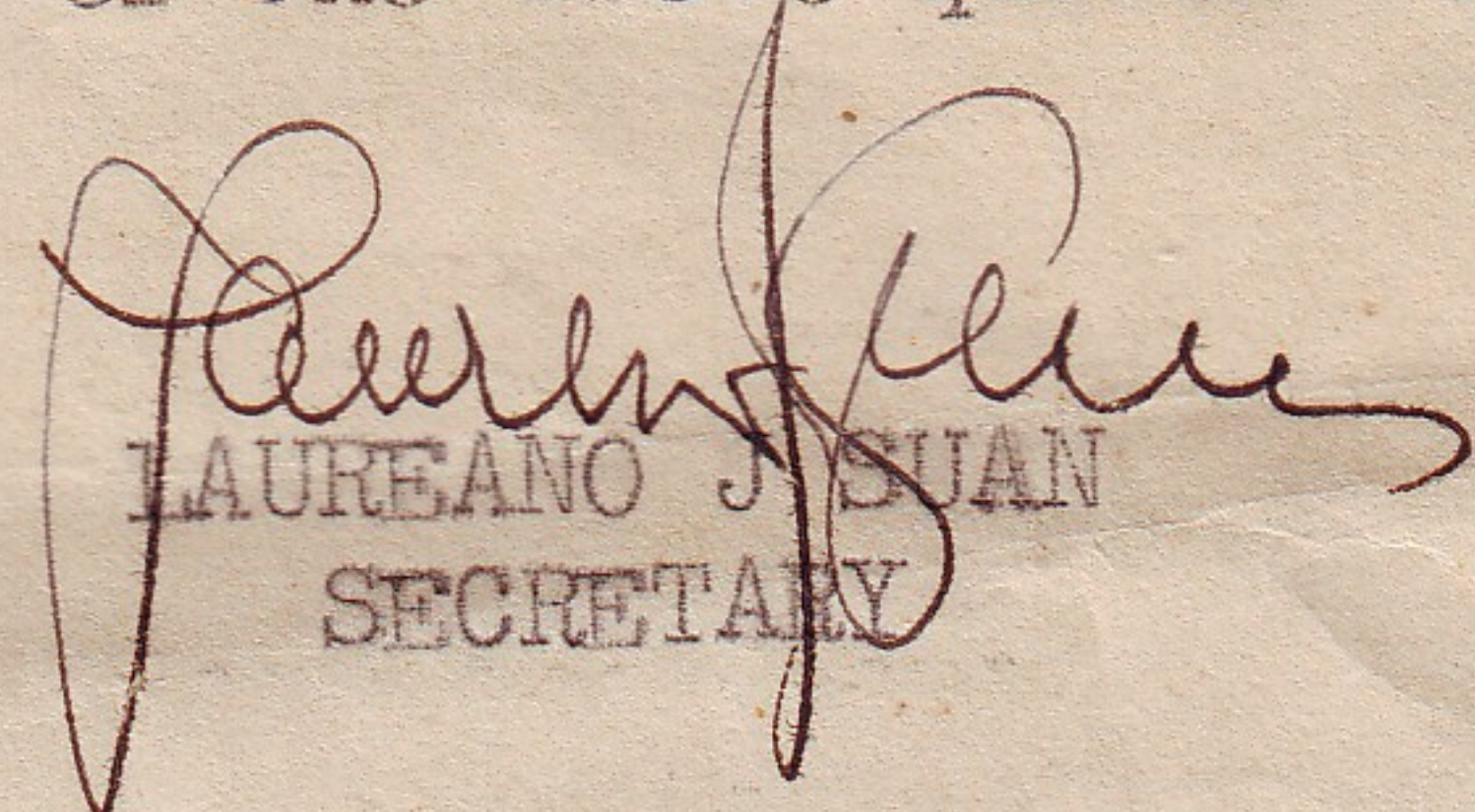
SECTION 2. This Ordinance shall take effect as of July 1, 1969.

ENACTED, September 10, 1969.

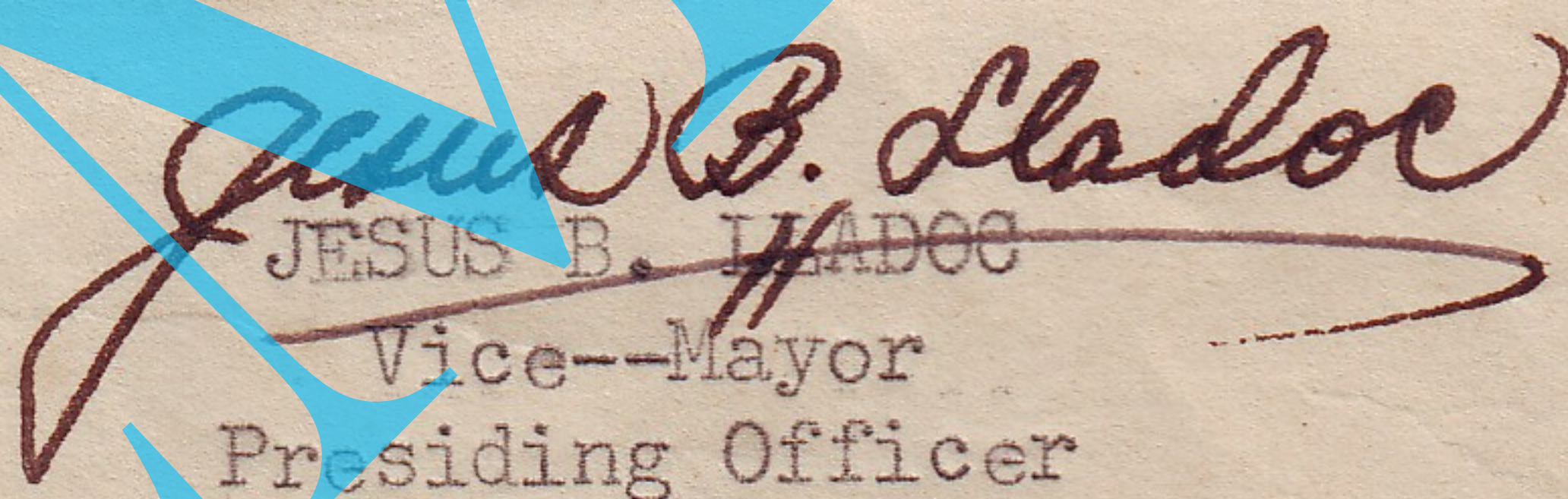

"CARRIED UNANIMOUSLY."

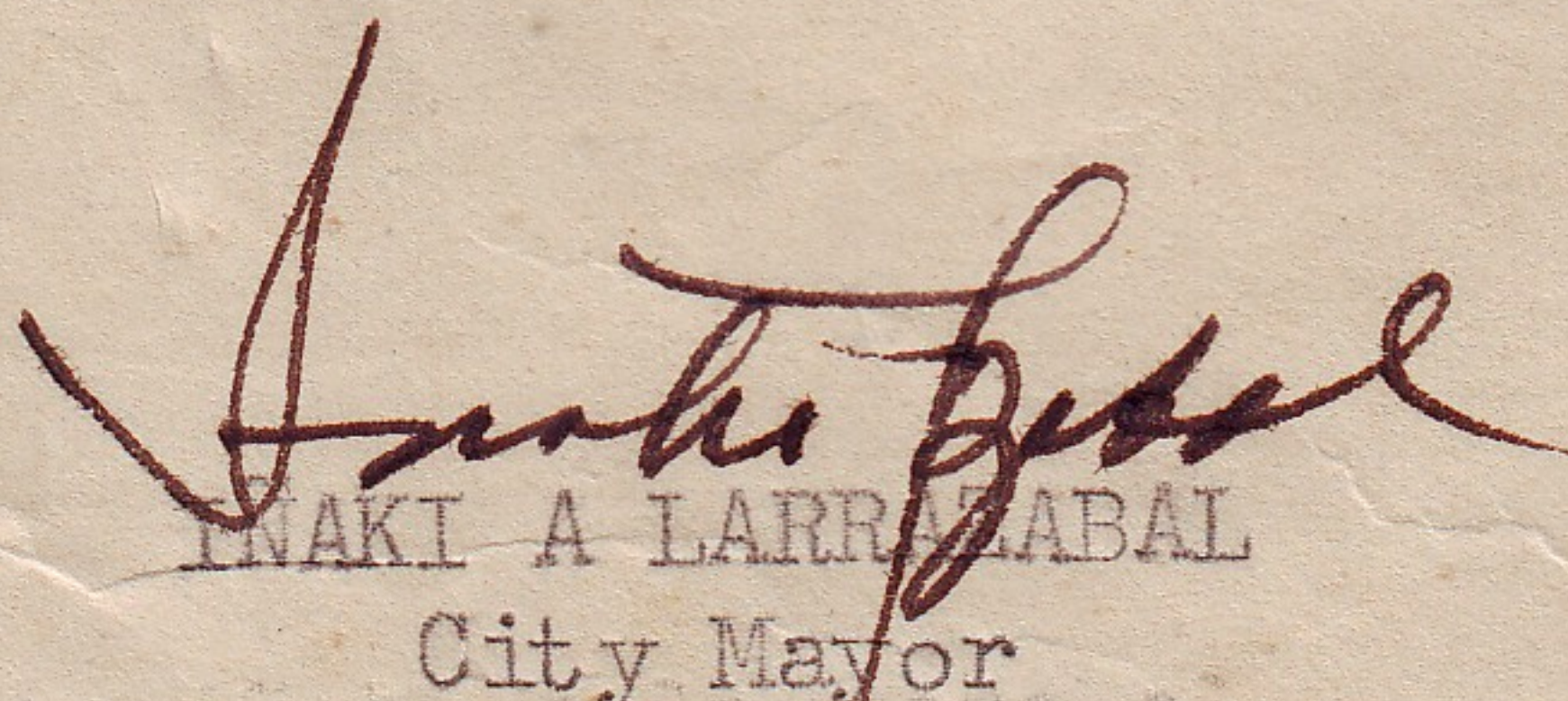

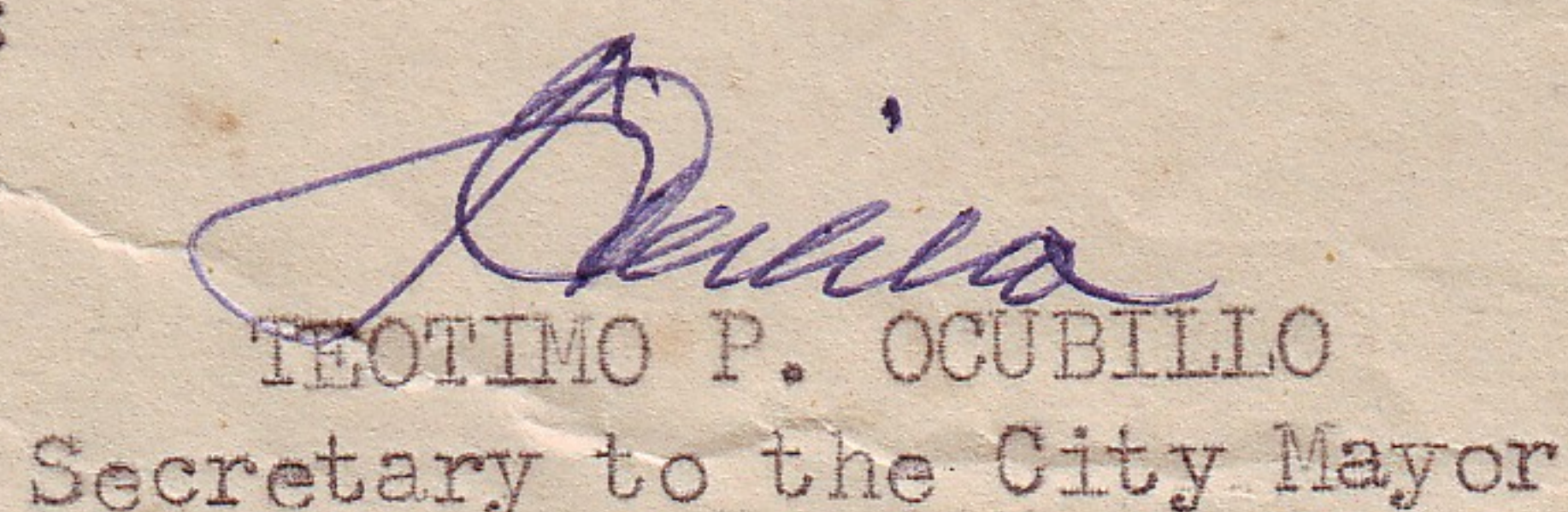
