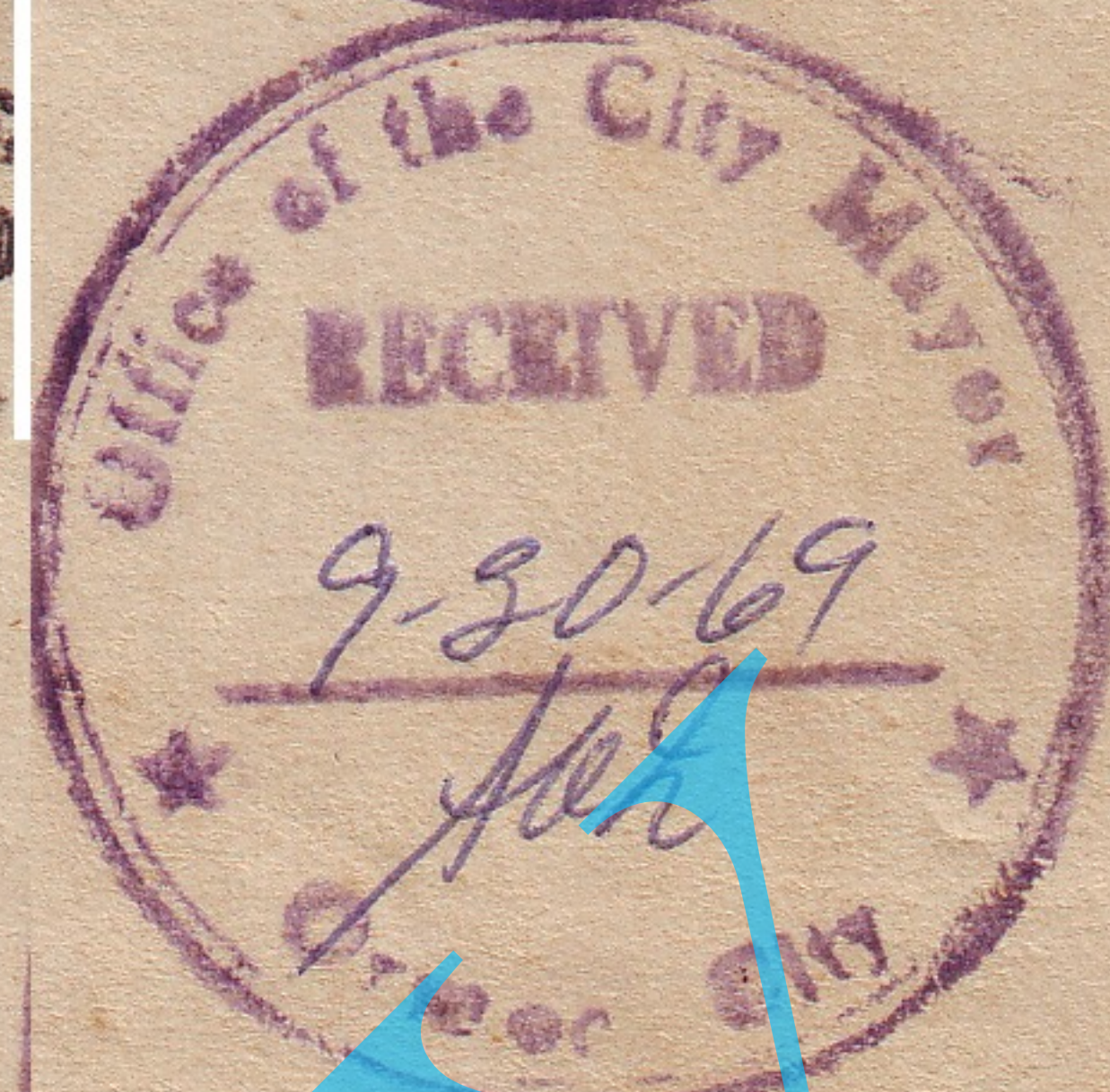


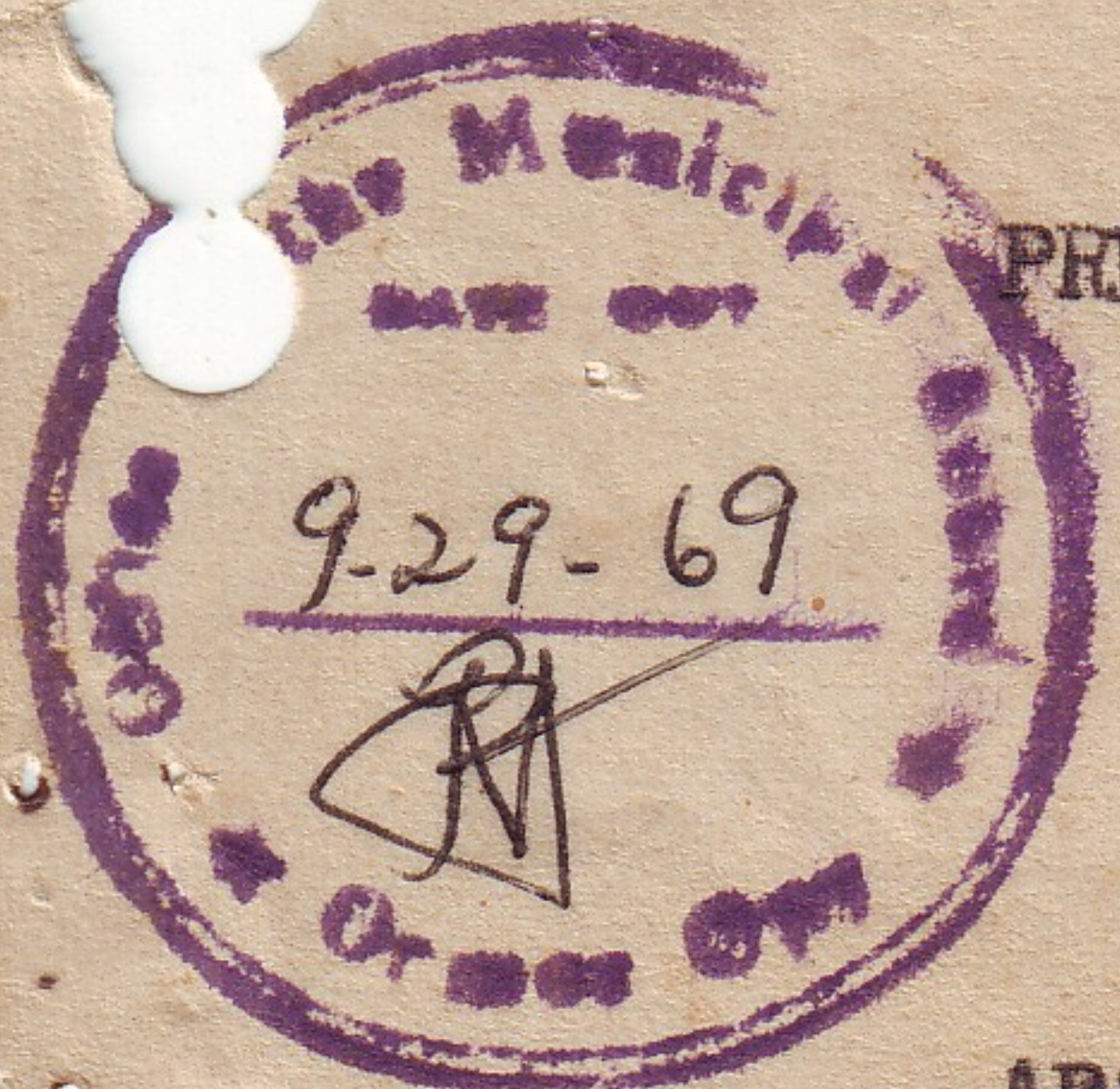

RESOLUTION NO. 131

"WHEREAS, the City Auditor in a communication dated September 15, 1969, has requested the reversion of the position of Administrative Officer back to its former designation of Senior Clerk in his department in view of the objection of the Auditor General to such new position it appearing that the personnel concerned does not possess Supervisor or any First Grade eligibility which may be considered appropriate for appointment to the position of Administrative Officer;

"NOW, THEREFORE, on motion of Councilor Percadilla, jointly seconded by Councilors Kangleen and Aviles;

"RESOLVED, to adopt:

ORDINANCE NO. 46

AN ORDINANCE AMENDING ITEM NO. 3 OF (C-3) AUDITING DEPARTMENT, UNDER ORDINANCE NO. 36, CURRENT SERIES, OTHERWISE KNOWN AS THE 1969-1970 ORMOC CITY BUDGET.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Item No. 3 of (C-3) Auditing Department, Page 5, under Section 2 of Ordinance No. 36, current series, otherwise known as the 1969-1970 Ormoc City Budget, is hereby amended to read as follows:

"3 : 3 Senior Clerk (from P3,360.00) 1 P 3,480.00"

SECTION 2. This Ordinance shall take effect immediately upon its approval.
