RESOLUTION NO. 133

"WHEREAS, District Judge Jose D. Nepomuceno of Branch VII, Naval, Leyte, now detailed at the Court of First Instance, Branch V, Ormoc City, after having made representations with the Honorable Secretary of Justice had been authorized to avail himself of gasoline allowances from City fund, in accordance with Memorandum Circular No. 191 of the Office of the President of the Philippines dated June 10, 1968;

"NOW, THEREFORE, on motion of Councilor Kangleon, jointly seconded by Councilors Aviles and Mejia;

"RESOLVED, to adopt:

ORDINANCE NO. 47

AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND ONE HUNDRED PESOS FROM OUT OF SALARY SAVINGS IN (C-25a) AGRICULTURAL EXTENSION SERVICE, 1969-1970 ORMOC CITY BUDGET, TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR GASOLINE ALLOWANCE OF CFI JUDGE JOSE D. NEPOMUCENO.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one thousand one hundred pesos (P1,100.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings in (C-25a) Agricultural Extension Service, 1969-1970 Ormoc City Budget, said sum to be made available as supplemental appropriation for gasoline allowance of District Judge Jose D. Nepomuceno of Branch VII, Naval, Leyte, now detailed at the Court of First Instance, Branch V, Ormoc City, in accordance with Memorandum Circular No. 191 dated June 10, 1968, of the Office of the President of the Philippines.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
