RESOLUTION NO. 145

"WHEREAS, the Chief of Fire Department in a letter dated November 27, 1969, had requested additional appropriation of P480.00 for telephone rentals of his office and residence inasmuch as the current appropriation has been charged to the previous accounts of his department to pay the Government Telephone System by the City Treasurer under authority of Resolution No. 105, current series;

"WHEREAS, telephone service is very essential to the Fire Department in the exigency of public service;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by Councilor Samson;

"RESOLVED, to adopt:

ORDINANCE NO. 52

AN ORDINANCE REVERTING THE SUM OF FOUR HUNDRED EIGHTY PESOS (P480.00) FROM OUT OF SALARY SAVINGS IN (C-16) FIRE DEPARTMENT TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR TELEPHONE RENTALS OF THE OFFICE AND RESIDENCE OF THE CHIEF OF FIRE DEPARTMENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of four hundred eighty pesos (P480.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings in (C-16) Fire Department, 1969-1970 Ormoc City Budget, to be made available as supplemental appropriation for telephone rentals of the office and residence of the Chief of Fire Department.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, December 10, 1969.
