RESOLUTION NO. 15

"WHEREAS, the City Treasurer has forwarded to this august Body a letter from the Office of the City Mayor pertaining to four checks amounting to sixteen thousand six hundred eighty-one pesos and forty-eight centavos (P16,681.48) representing shares of the City from the Philippine Charity Sweepstakes draws which the Honorable City Mayor would like to be distributed as follows: P9,681.48 to the Ormoc General Hospital for the installation of a jet-matic water pump, repair of the ambulance, and others; P3,000.00 for the Ormoc Puericulture Center and Maternity House; and P4,000.00 for the City Health Department, as allowed by law and standing regulations;

"NOW, THEREFORE, on motion of the Floor Leader, seconded by Councilor Kangleon;

"RESOLVED, to adopt:

ORDINANCE NO. 6

AN ORDINANCE APPROPRIATING THE SUM OF SIXTEEN THOUSAND SIX HUNDRED EIGHTY-ONE PESOS AND FORTY-EIGHT CENTAVOS (P16,681.48) FOR DISTRIBUTION TO THE ORMOC GENERAL HOSPITAL, ORMOC PUERICULTURE CENTER AND MATERNITY HOUSE, AND CITY HEALTH DEPARTMENT FROM OUT OF THE CITY'S SHARES FROM PHILIPPINE CHARITY SWEEPSTAKES DRAWS.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of sixteen thousand six hundred eighty-one pesos and forty-eight centavos (P16,681.48), or so much thereof as may be necessary, is hereby appropriated from out of the shares of the city from the Philippine Charity Sweepstakes draws to be made available for distribution as follows:

a) Ormoc General Hospital .....	P 9,681.48
b) Ormoc Puericulture Center and Maternity House .....	3,000.00
c) City Health Department .....	4,000.00
Total .....	P16,681.48

SECTION 2. This Ordinance shall take effect immediately upon its approval.





"CARRIED UNANIMOUSLY."


