RESOLUTION NO. 19

"WHEREAS, the Honorable Chairman of the Committee on Education, Councilor Albino P. Porcadilla, has reported that the Barrio Captain of Barrio Cabaon-an, this City, has made representations for an appropriation of two hundred pesos (P200.00) to be made available for the purchase of some forty (40) sheets of galvanized iron roofing materials in order to give their school children a decent school building and free them from the sun and the rain;

"WHEREAS, Honorable Jose C. Aviles, Councilor In Charge of Barrio Cabaon-an, in this connection, has reported that this request of the Barrio Captain of Barrio Cabaon-an came out of necessity after the barrio had supplied and saved labor in the repair of the school building amounting to one hundred fifteen pesos (P115.00) aside from the barrio school aid in the amount of one hundred pesos (P100.00) which was granted by Councilor Aviles for the construction of the framework of the school building;

"NOW, THEREFORE, on motion of Councilor Porcadilla, seconded by Councilor Aviles;

"RESOLVED, to adopt:

ORDINANCE NO. 8

AN ORDINANCE REVERTING THE SUM OF TWO HUNDRED PESOS (P200.00) FROM OUT OF ITEM NO. 12 OF THE AIDS AND TRANSFER OF FUNDS, 1968-1969 ORMOC CITY BUDGET, TO BE MADE AVAILABLE AS SCHOOL AID TO BARRIO CABAON-AN FOR THE PURCHASE OF FORTY (40) SHEETS OF GALVANIZED IRON ROOFING MATERIALS FOR THE NEWLY REPAIRED BARRIO SCHOOL BUILDING.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of two hundred pesos (P200.00), or so much thereof as may be necessary, is hereby reverted from out of Item No. 12 of the Aids and Transfer of Funds, page 14, 1968-1969 Ormoc City Budget, said sum to be made available for appropriation as school aid to Barrio Cabaon-an, Ormoc City, for the purchase of forty (40) sheets of galvanized iron roofing materials for the newly repaired barrio school building.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
