RESOLUTION NO. 20

"WHEREAS, the Barrio Captain of Barrio Bantigue, has made representations with this Board for an aid to repair the barrio school building in order to make it more conducive to learning;

"NOW, THEREFORE, on motion of Councilor Porcadilla, jointly seconded by Councilor Aviles and the Floor Leader;

"RESOLVED, to adopt:

ORDINANCE NO. 9

AN ORDINANCE REVERTING THE SUM OF TWO HUNDRED PESOS (P200.00) FROM OUT OF ITEM NO. 12 OF THE AIDS AND TRANSFER OF FUNDS, 1968-1969 ORMOC CITY BUDGET, TO BE MADE AVAILABLE FOR SCHOOL AID TO BARRIO BANTIGUE FOR THE REPAIR OF THE COMMUNITY SCHOOL BUILDING.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of two hundred pesos (P200.00), or so much thereof as may be necessary, is hereby reverted from out of Item No. 12 of the Aids and Transfer of Funds, page 14, 1968-1969 Ormoc City Budget, to be made available for appropriation as school aid to Barrio Bantigue for the repair of the community school building.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
