RESOLUTION NO. 1

"WHEREAS, the Secretary to the City Mayor in his letter dated December 11, 1969, has requested an appropriation of ₱1,800.00 to cover his representation allowances for the current fiscal year, in accordance with Memorandum Circular No. 273 dated July 22, 1969, of the Office of the President of the Philippines, which he quoted verbatim, to wit:

'Memorandum Circular No. 138 of this Office dated December 15, 1967, as amended by Memorandum Circulars Nos. 255 and 270 dated April 23, 1969 and June 30, 1969, respectively, prescribing the policy regarding the grant of representation allowances to certain local government officials, is hereby further amended so as to include secretaries to the City Mayors among the officials entitled to representation allowances at the same rates prescribed in said Memorandum Circular No. 255.

"RESOLVED, to adopt:

ORDINANCE NO. 1

AN ORDINANCE REVERTING THE SUM OF ₱1,800.00 FROM OUT OF SALARY SAVINGS IN (C-1) OFFICE OF THE CITY MAYOR TO BE MADE AVAILABLE FOR SUPPLEMENTAL APPROPRIATION FOR REPRESENTATION ALLOWANCE OF THE SECRETARY TO THE CITY MAYOR IN ACCORDANCE WITH MEMORANDUM CIRCULAR NO. 273 DATED JULY 22, 1969, OF THE OFFICE OF THE PRESIDENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one thousand eight hundred pesos (₱1,800.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings in (C-1) Office of the City Mayor, current appropriations, said sum to be made available for supplemental appropriation for representation allowance of the Secretary to the City Mayor in accordance with Memorandum Circular No. 273 dated July 22, 1969, of the Office of the President of the Philippines: Provided, however, That this item shall be incorporated in subsequent general appropriations ordinance.

SECTION 2. This Ordinance shall take effect as of July 1, 1969.

ENACTED, January 7, 1970.
