RESOLUTION NO. 17

"WHEREAS, the Chief of Fire Department in his communication of January 22, 1970, has informed this august Body that the electrician lineman, Mr. Antonio Bola, had resigned from the said position in his department which resignation was duly approved by the Honorable City Mayor on January 5, 1970;

"WHEREAS, considering the exigency of the position in the Fire Department, the Honorable City Mayor immediately appointed Mr. Sergio A. Sabelino on January 6, 1970, vice Mr. Antonio Bola;

"WHEREAS, Mr. Bola was able to receive his terminal leave pay from out of the item of his position for the period covering up to June 30, 1970, thereby leaving Mr. Sabelino's appointment without funds any more so much so that the Chief of Fire Department has requested the reversion of P1,020.00 from out of the salary savings accruing to the unfilled position of one laborer in his department said sum to be made available as supplemental appropriation for salaries and wages of Mr. Sabelino with the same rate of compensation as Mr. Bola's two thousand forty pesos (P2,040.00) per annum;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by Councilor Samson;

"RESOLVED, to approve the request of the Chief of Fire Department and do, as this Body hereby does, adopt:

ORDINANCE NO. 12

AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND TWENTY PESOS (P1,020.00) FROM OUT OF THE SALARY SAVINGS IN THE UNFILLED POSITION OF ONE LABORER IN THE FIRE DEPARTMENT TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR SALARIES AND WAGES OF MR. SERGIO A. SABELINO, ELECTRICIAN LINEMAN.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one thousand twenty pesos (P1,020.00), or so much thereof as may be necessary, is hereby reverted from out of the salary savings in the unfilled position of one laborer in the Fire Department, said sum to be made available as supplemental appropriation for salaries and wages of Mr. Sergio A. Sabelino, electrician lineman, vice Mr. Antonio Bola, resigned, with compensation at the rate of two thousand forty pesos (P2,040.00) per annum.
