ORDINANCE NO. 13

AN ORDINANCE REVERTING THE SUM OF EIGHT HUNDRED PESOS (P800.00) FROM
OUT OF SALARY SAVINGS IN THE HEALTH DEPARTMENT TO BE MADE AVAIL-
ABLE AS SUPPLEMENTAL APPROPRIATION FOR SOME CONTINGENT EXPENSES
OF THE SAME DEPARTMENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of eight hundred pesos (P800.00), or so much
thereof as may be necessary, is hereby reverted from out of salary
savings in the Health Department, said sum to be made available as
supplemental appropriation for some contingencies of the same depart-
ment in the manner provided hereunder as follows:

a) Overhauling, repair and maintenance of station wagon	P500.00
b) Office supplies and materials	300.00
Total	P800.00

SECTION 2. This Ordinance shall take effect immediately upon its
approval.
