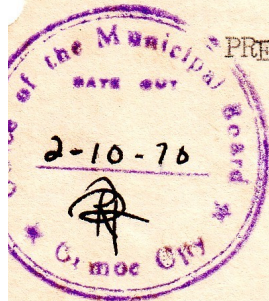
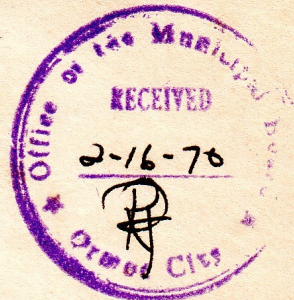

RESOLUTION NO. 20

"WHEREAS, quite a number of market goers, especially housewives, have been complaining of shortchanging manipulated by fraudulent dealers of commodities such that what they purchase are underweight by so many grams or ounces;

"WHEREAS, it has been a long dream and project of this august Body to establish or install an official standard weight in the public market for people to check whether they are being shortchanged or cheated whenever they buy something;

"WHEREAS, the installation of an official standard weight in the public market will eventually eliminate cheating in the sale of commodities which must have been long going on in the said market to the prejudice of honest and scrupulous vendors who have been plying their trade religiously;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by the Floor Leader;

"RESOLVED, to establish or install an official standard weight in the public market and do, as this Body hereby does, adopt:

ORDINANCE NO. 14

AN ORDINANCE REVERTING THE SUM OF FIVE HUNDRED FIFTY PESOS (P550.00) FROM OUT OF SALARY SAVINGS ACCRUING TO (C-25a) AGRICULTURAL EXTENSION SERVICE TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR THE PURCHASE OF AN OFFICIAL STANDARD WEIGHT FOR INSTALLATION IN THE PUBLIC MARKET.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of five hundred fifty pesos (P550.00), or so much thereof as may be necessary, is hereby reverted from out of the salary savings accruing to (C-25a) Agricultural Extension Service, said sum to be made available as supplemental appropriation for the purchase of one (1) official standard weight for installation in the public market.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
