RESOLUTION NO. 24

"WHEREAS, this august Body will remember having been in receipt of a petition of five hundred fifty-two inhabitants of Sitio Hantatamsi, formerly Badlas, of Barrio Alegria, this City, which is quoted verbatim hereunder as follows:

Republic of the Philippines
SITIO HANTATAMSI, BARRIO ALEGRIA
Ormoc City

P E T I T I O N

"TO: The Honorable Municipal Board
Ormoc City
(Thru His Honor, the City Mayor)

"WE, the residents of Sitio Hantatamsi, formerly Badlas, Barrio Alegria, Ormoc City, do hereby respectfully petition the Honorable Municipal Board, through His Honor, the Mayor, of Ormoc City, that this sitio wherein we reside be converted into a BARRIO to be named after the late Don FELIPE LARRAZABAL for the following reasons:

"(1) That we comprise more than five hundred (500) inhabitants, as required by Republic Act No. 3590, otherwise known as the Revised Barrio Charter, the fact that we have also two electoral precincts numbered 84 and 84-A as evidenced in the last national elections;

(2) That we are ready to separate from our mother barrio Alegria and organize a barrio of our own among ourselves in Hantatamsi;

"(3) That we choose the name of the late Don FELIPE LARRAZABAL for our barrio considering that the late Don Felipe had contributed much to progress, prosperity, welfare and fame of Ormoc City in particular, and the Philippines in general, by bringing into this world prominent sons who have served and are still serving their people, namely, Don Potenciano A. Larrazabal, ex-City Mayor; Hon. Feliciano A. Larrazabal, incumbent Municipal Mayor of Kananga, Leyte; Hon. Iñaki A. Larrazabal, incumbent Ormoc City Mayor; Mr. Melchor A. Larrazabal, Barrio Captain of Hibunaon, and Sabin Larrazabal, Barrio Captain of Biliboy;

"IN WITNESS WHEREOF, we have hereunto signed this petition this 26th day of November, 1969, in the City of Ormoc, Philippines.

"WHEREAS, considering that the foregoing petition is well taken and in consonance with Republic Act 3590, otherwise known as the Revised Barrio Charter, a public hearing was immediately conducted with the barrio officials of Alegria and residents of Sitio Hantatamsi wherein said officials were unanimous in giving away and granting independence to Sitio Hantatamsi and with their consent the new barrio to be created and named after the late Don Felipe Larrazabal will comprise the whole of Hantatamsi and, by way of a sketch map now submitted as Exhibit "A", its surrounding boundaries have been defined in its relation to the mother barrio of Alegria in the south, Barrio Punta in the west, and Barrio Cogon Combado in the north, and Anilao River in the east;

"NOW, THEREFORE, on motion of Councilor Porcadilla, seconded by Councilor Samson;

"RESOLVED, to grant the petition of the inhabitants of Sitio Hantatamsi, Barrio Alegria, this City, and do, as this Body hereby does, adopt:

ORDINANCE NO. 16

AN ORDINANCE CREATING THE BARRIO OF DON FELIPE LARRAZABAL FROM OUT OF SITIO HANTATAMSI OF BARRIO ALEGRIA, ORMOC CITY, DEFINING ITS SURROUNDING BOUNDARIES IN RELATION TO ITS MOTHER BARRIO OF ALEGRIA IN THE SOUTH, BARRIO PUNTA IN THE WEST, BARRIO COGON COMBADO IN THE NORTH, AND ANILAO RIVER IN THE EAST BY MEANS OF A SKETCH MAP SUBMITTED AND MARKED AS EXHIBIT "A".

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Barrio Don Felipe Larrazabal is hereby created from out of Sitio Hantatamsi of Barrio Alegria, Ormoc City, with its surrounding boundaries in relation to its mother barrio of Alegria in the south, Barrio Punta in the east, Barrio Cogon Combado in the north, and Anilao River in the east defined by means of a sketch map submitted and marked as Exhibit "A" for all intents and purposes.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, February 18, 1970.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to His Excellency, the President of the Philippines, and the Honorable Executive Secretary, both of Malacañang, and the Director of Lands, all of Manila; the District Land Officer, Bureau of Lands, Tacloban City; the City Assessor, the City Engineer, the City Treasurer, the City Auditor, the Barrio Council of Barrio Alegria, and the petitioners, all of Ormoc City;
