RESOLUTION NO. 26

"WHEREAS, the Deputy Chief of Police in a letter dated February 10, 1970, has requested an appropriation of P500.00 for office supplies of his department following the rejection of his latest requisition for the same item for lack of funds after the current appropriation has been exhausted;

"WHEREAS, office supplies are indeed necessary for the smooth functioning of the Ormoc City Police Department;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by Councilor Samson;

"RESOLVED, to adopt:

ORDINANCE NO. 18

AN ORDINANCE REVERTING THE SUM OF FIVE HUNDRED PESOS (P500.00) FROM OUT OF SALARY SAVINGS IN THE POLICE DEPARTMENT TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR OFFICE SUPPLIES OF THE SAID DEPARTMENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of five hundred pesos (P500.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings in the Police Department, said sum to be made available as supplemental appropriation for office supplies of said department.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
