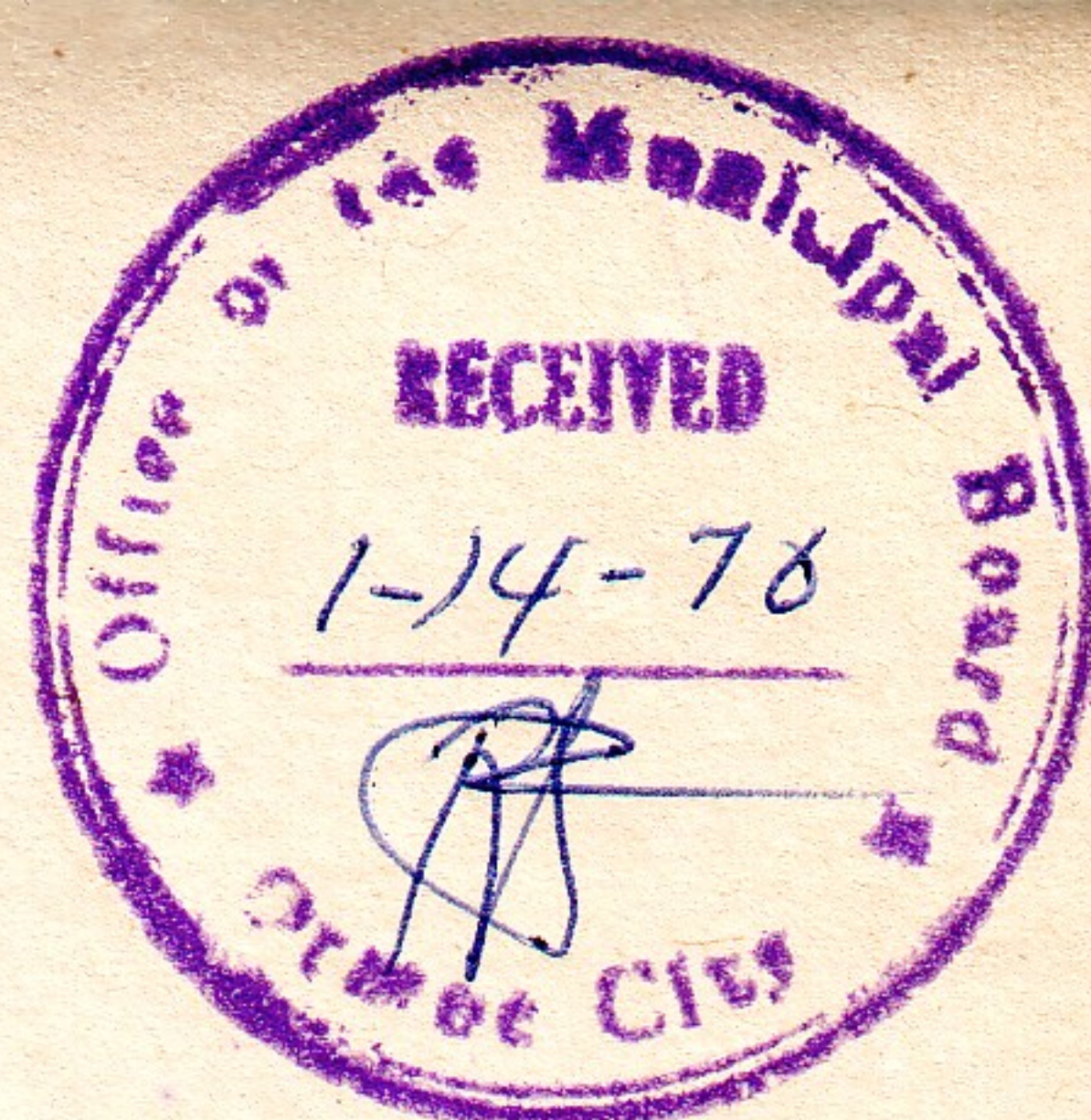

RESOLUTION NO. 2

"WHEREAS, the Deputy Chief of Police in his communication dated December 16, 1969, has informed this august Body and the Honorable City Mayor that he has been receiving the rate of compensation at ₱6,000.00 per annum instead of ₱6,800.00 as provided for in the City Budget effective July 1, 1968, so that he is entitled to a salary difference of ₱732.00, excluding life insurance premiums, for the 1968-1969 fiscal year;

"WHEREAS, the Deputy Chief of Police in the same communication has attached a certified true copy of his appointment approved by the Commissioner of Civil Service on account of which the City is under obligation to pay his salary difference for the period from July 1, 1968, up to and including June 30, 1969;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by the Floor Leader;

"RESOLVED, to adopt:

ORDINANCE NO. 2

AN ORDINANCE REVERTING THE SUM OF ₱732.00 FROM OUT OF SALARY SAVINGS IN (C-15) POLICE DEPARTMENT TO BE MADE AVAILABLE FOR SUPPLEMENTAL APPROPRIATION TO COVER OUTSTANDING OBLIGATION TO THE DEPUTY CHIEF OF POLICE IN PAYMENT OF HIS SALARY DIFFERENCE FROM ₱6,000.00 TO ₱6,800.00 PER ANNUM FOR THE PERIOD FROM JULY 1, 1968, TO JUNE 30, 1969, INCLUSIVE.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of seven hundred thirty-two pesos (₱732.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings in (C-15) Police Department, said sum to be made available for supplemental appropriation to cover outstanding obligation to the Deputy Chief of Police in payment of his salary difference from ₱6,000.00 to ₱6,800.00 per annum for the period from July 1, 1968, up to and including June 30, 1969.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, January 7, 1970.


