RESOLUTION NO. 31

"WHEREAS, the Supervising Management Analyst I and In Charge, Office of the City Treasurer, in a communication dated February 25, 1970, has requested the reversion of P200.00 from out of the item on Treasurer's office annex to be made available for supplemental appropriation for traveling allowances of market collectors detailed in the Valencia public market every Sunday inasmuch as the current appropriation for this purpose had already been exhausted since November of last year;

"NOW, THEREFORE, on motion of Councilor Kangleen, seconded by Councilor Samson;

"RESOLVED, to approve the request of the Supervising Management Analyst I and In Charge, Office of the City Treasurer, and do, as this Body hereby does, adopt:

ORDINANCE NO. 21

AN ORDINANCE REVERTING THE SUM OF TWO HUNDRED PESOS (P200.00) FROM OUT OF THE ITEM ON TREASURER'S OFFICE ANNEX TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR TRAVELING ALLOWANCES OF MARKET COLLECTORS DETAILED IN THE VALENCIA PUBLIC MARKET.

BE IT ORDAINED, by the Municipal Board, of Ormoc City, That:

SECTION 1. The sum of two hundred pesos (P200.00), or so much thereof as may be necessary, is hereby reverted from out of the item on Treasurer's office annex (Item No. 31, Finance Department), said sum to be made available as supplemental appropriation for traveling allowances of market collectors detailed in the Valencia public market.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
