RESOLUTION NO. 33

"WHEREAS, the City Auditor in his communication of March 3, 1970, has requested the reversion of P1,020.00 from salary savings of his department to be made available as supplemental appropriation of P500.00 for supplies and materials and P520.00 for other services in order that they could provide themselves with the necessary receptacles for account papers of the city treasurer and all national collecting officers under his audit jurisdiction and, further, employ extra working hands to file these papers in proper order considering that there are 100 packages and 30 big cartons and wooden boxes containing old accounts from 1945 to 1967;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by Councilor Samsen;

"RESOLVED, to approve the request of the City Auditor and do, as this Body hereby does, adopt:

ORDINANCE NO. 22

AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND TWENTY PESOS (P1,020.00) FROM OUT OF SALARY SAVINGS IN THE AUDITING DEPARTMENT TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR CERTAIN CONTINGENT EXPENSES OF THE SAME DEPARTMENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one thousand twenty pesos (P1,020.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings in the Auditing Department, said sum to be made available as supplemental appropriation for contingent expenses of the same department in the manner provided hereunder as follows:

- a) Supplies and materials ..... P 500.00
- b) Other services ..... 520.00 P 1,020.00

SECTION 2. This Ordinance shall take effect immediately upon its approval.
