RESOLUTION NO. 34

"WHEREAS, the City Judge in a letter of March 3, 1970, has requested the reversion of P500.00 from out of the item on his travel and transportation to be made available as supplemental appropriation for certain contingent expenses in his department which request is highly commendable considering that the City Judge has shown his willingness to sacrifice his travel and transportation in the interest of the administration of justice;

"NOW, THEREFORE, on motion of Councilor Kangleon, jointly seconded by Councilor Mejia and the Floor Leader;

"RESOLVED, to approve the request of the City Judge and do, as this Body hereby does, adopt:

ORDINANCE NO. 23

AN ORDINANCE REVERTING THE SUM OF FIVE HUNDRED PESOS (P500.00) FROM OUT OF THE ITEM ON TRAVEL AND TRANSPORTATION OF THE CITY COURT TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR CERTAIN CONTINGENT EXPENSES OF THE SAME DEPARTMENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of five hundred pesos (P500.00), or so much thereof as may be necessary, is hereby reverted from out of the item on travel and transportation of the City Court, said sum to be made available as supplemental appropriation for contingent expenses in the same department in the manner provided hereunder as follows:

a) Office supplies and materials	P250.00
b) Communication (postage stamps and telegrams).	150.00
c) Subscription to law journals, official gazette, etc.)	50.00
d) Emergency repairs of typewriters and other office equipment	50.00
	P500.00

SECTION 2. This Ordinance shall take effect immediately upon its approval.
