RESOLUTION NO. 39

"WHEREAS, the Waterworks Supervisor in a communication dated March 9, 1970, had requested the reversion of P18,700.00 from out of the item on DBP loan amortization of his department for the improvement of our waterworks system so that all projects including additional sources from Ahag, Teon and Mahayag springs will be completed before the end of the current fiscal year;

"WHEREAS, some P4,800.00 had already been reverted from out of this item for the implementation of the Minimum Wage Law to our employees and this august Body believes that P10,000.00 would be sufficient for the improvement of the waterworks system;

"NOW, THEREFORE, on motion of Councilor Aviles, jointly seconded by Councilor Samson and the Floor Leader;

"RESOLVED, to adopt:

ORDINANCE NO. 26

AN ORDINANCE REVERTING THE SUM OF TEN THOUSAND PESOS (P10,000.00) FROM OUT OF THE ITEM ON DBP LOAN AMORTIZATION OF THE ORMOC CITY WATERWORKS SYSTEM TO BE MADE AVAILABLE FOR IMPROVEMENT OF THE SYSTEM.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of ten thousand pesos (P10,000.00), or so much thereof as may be necessary, is hereby reverted from out of the item on DBP loan amortization of the Ormoc City Waterworks System, said sum to be made available as supplemental appropriation for the improvement of the system as requested by the Waterworks Supervisor.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, March 18, 1970.
