RESOLUTION NO. 39

"WHEREAS, the Waterworks Supervisor in a communication dated March 9, 1970, had requested the reversion of \$18,700.00 from out of the item on DBP loan amortization of his department for the improvement of our waterworks system so that all projects including additional sources from Ahag, Teon and Mahayag springs will be completed before the end of the current fiscal year;

"WHEREAS, some \$4,800.00 had already been reverted from out of this item for the implementation of the Minimum Wage Law to our employees and this august Bedy believes that \$10,000.00 would be sufficient for the improvement of the waterworks system;

"NOW, THEREFORE, on motion of Councilor Aviles, jointly seconded by Councilor Samson and the Floor Leader;

"RESOLVED, to adopt:

CRDINANCE NO. 26

AN ORDINANCE REVERTING THE SUM OF TEN THOUSAND PESOS (\$10,000.00) FROM OUT OF THE ITEM ON DBP LOAN AMORTIZATION OF THE ORMOC CITY WATER-WORKS SYSTEM TO BE MADE AVAILABLE FOR IMPROVEMENT? OF THE SYSTEM.

RE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of ten thousand peses (\$10,000.00), or so much thereof es may be necessary, is hereby reverted from out of the item en DBP loan amortization of the Ormoc City Waterworks System, said sum to be made available as supplemental appropriation for the improvement of the system as requested by the Waterworks Supervisor.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
