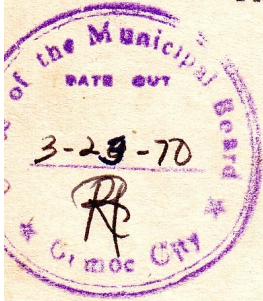

RESOLUTION NO. 42

"WHEREAS, the City Fiscal in his communication dated March 17, 1970, has requested the reversion of P200.00 from out of the item on repair of office equipment in his department to be made available for his travel and transportation inasmuch as the latter item has already been exhausted;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by Councilor Porcadilla;

"RESOLVED, to approve the request of the City Fiscal and do, as this Body hereby does, adopt:

ORDINANCE NO. 27

AN ORDINANCE REVERTING THE SUM OF TWO HUNDRED PESOS (P200.00) FROM OUT OF THE ITEM ON REPAIR OF OFFICE EQUIPMENT IN THE LAW DEPARTMENT TO BE MADE AVAILABLE FOR SUPPLEMENTAL APPROPRIATION FOR TRAVEL AND TRANSPORTATION OF THE SAME DEPARTMENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of two hundred pesos (P200.00), or so much thereof as may be necessary, is hereby reverted from out of the item on repair of office equipment in the Law Department, said sum to be made available as supplemental appropriation for travel and transportation of the same department, as requested by the City Fiscal.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
