RESOLUTION NO. 4

"WHEREAS, the Officer in Charge of the Finance Department in his letter dated January 12, 1970, has, among other things, requested the reversion of P5,710.00 from out of salary savings in his department to be made available for supplemental appropriations for items which have already been exhausted in the ~~current~~ appropriation for contingent expenses;

"RESOLVED, to approve the request of the Officer in Charge, Finance Department, and do, as this Body hereby does, adopt:

ORDINANCE NO. 3

AN ORDINANCE REVERTING THE SUM OF P5,710.00 FROM OUT OF SALARY SAVINGS IN (C-5) FINANCE DEPARTMENT TO BE MADE AVAILABLE FOR SUPPLEMENTAL APPROPRIATION FOR SUPPLIES, TRAVEL AND TRANSPORTATION, COMMUNICATIONS, AND OTHER SERVICES OF THE SAID DEPARTMENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of five thousand seven hundred ten pesos (P5,710.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings in (C-5) Finance Department to be made available for supplemental appropriation for certain items under Contingent Expenses of the said department, vis-a-vis:

a) Supplies and materials .....	P3,500.00	
b) Travel and transportation ..	1,500.00	
c) Communications .....	310.00	
d) Other services .....	400.00	P5,710.00

SECTION 2. This Ordinance shall take effect immediately upon its approval.
