BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of five thousand seven hundred ten pesos (#5,-710.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings in (C-5) Finance Department to be made a vailable for supplemental appropriation for certain items under Contingent Expenses of the said department, vis-a-vis:

a) Supplies and materials ₱3,500.00

b) Travel and transportation .. 1,500.00
