## RESOLUTION NO. 58

"WHEREAS, the City Auditor in a letter dated April 21, 1970, has requested the reversion of P1,020.00 from salary savings of his department (Item 5) to be made available for additional appropriation of P200 for supplies and materials, P320 for other services and P500.00 for travel and transportation, which this august Body finds worthy of our consideration in view of the urgency of the request as elaborately explained in said letter;

"RESOLVED, to approve the request of the City Auditor and do, as this Body hereby does, adopt:

## ORDINANCE NO. 30

AN ORDINANCE REVERTING THE SUM OF P1,020.00 FROM SALARY SAVINGS IN THE AUDITING DEPARTMENT TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR OTHER ITEMS UNDER CONTINGENT EXPENSES OF THE SAME DEPARTMENT AS REQUESTED BY THE CITY AUDITOR.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one thousand twenty pesos (P1,020.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings (Item 5) of the Auditing Department, said sum to be made available as supplemental appropriation in the manner provided hereunder as follows; under Contingent Expenses; as requested by the City Auditor:
