RESOLUTION NO. 60

"WHEREAS, the Officer in Charge of the City Finance Department has forwarded to this august Body Bill No. 20-70 dated April 28, 1970, of the Ormoc General Hospital in the amount of six hundred fifty-six pesos (P656.00) in connection with the hospitalization of Patrolman Saturnino Noya of the Ormoc City Police Department for the period from April 13 to 28, 1970, for gunshot and stab wounds which he sustained while effecting an arrest of a certain accused;

"WHEREAS, in view of the fact that the current city budget does not carry any appropriation for said hospitalization charges, the Officer in Charge of the City Finance Department has requested the reversion of the sum of P656.00 from out of the item on DBP loan amortization of the Ormoc City Waterworks System said sum to be made available as supplemental appropriation for this obligation to the Ormoc General Hospital;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by Councilor Aviles;

"RESOLVED, to approve the request of the Officer in Charge of the City Finance Department and do, as this Body hereby does, adopt:

ORDINANCE NO. 31

AN ORDINANCE REVERTING THE SUM OF SIX HUNDRED FIFTY-SIX PESOS (P656.00) FROM OUT OF THE ITEM ON DBP LOAN AMORTIZATION OF THE ORMOC CITY WATERWORKS SYSTEM TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION TO COVER BILL NO. 20-70 OF THE ORMOC GENERAL HOSPITAL IN CONNECTION WITH THE HOSPITALIZATION OF PATROLMAN SATURNINO NOYA OF THE ORMOC CITY POLICE DEPARTMENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of six hundred fifty-six pesos (P656.00), or so much thereof as may be necessary, is hereby reverted from out of the item on DBP loan amortization of the Ormoc City Waterworks System, said sum to be made available as supplemental appropriation to cover Bill No. 20-70 dated April 28, 1970, of the Ormoc General Hospital in connection with the hospitalization of Patrolman Saturnino Noya of the Ormoc City Police Department for the period from April 13 to 28, 1970, for gunshot and stab wounds which he sustained while effecting an arrest of a certain accused.


SECTION 2. This Ordinance shall take effect immediately upon its approval.




