RESOLUTION NO. 61

"WHEREAS, the City Health Officer in a communication dated April 30, 1970, addressed to the Honorable Presiding Officer of this august Body has humbly requested the reversion of part of salary savings of his department to cover up the deficiencies under contingent expenses of the same department itemized as follows:

Maintenance and repair of dispensary building	₱400.00
Illumination and power	674.00
Maintenance of CHO vehicles	290.00
Office supplies	195.00
Traveling expenses of personnel	46.00
Total	₱1,605.00

"WHEREAS, the Officer in Charge of the City Finance Department has issued a certification to the effect that the City Health Department, as of April 30, 1970, has salary savings even in the sum of one thousand six hundred ten pesos (₱1,600.00) which this august Body believes is more than sufficient to meet the requested reversion of the City Health Officer;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by Councilor Aviles;

"RESOLVED, to approve the request of the City Health Officer and do, as this Body hereby does, adopt:

ORDINANCE NO. 32

AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND SIX HUNDRED FIVE PESOS (₱1,605.00) FROM OUT OF SALARY SAVINGS OF THE CITY HEALTH DEPARTMENT TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION TO COVER UP DEFICIENCIES UNDER CONTINGENT EXPENSES OF THE SAME DEPARTMENT AS ITEMIZED BY THE CITY HEALTH OFFICER

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one thousand six hundred five pesos (₱1,605), or so much thereof as may be necessary, is hereby reverted from out of the salary savings of the City Health Department, said sum to be made available as supplemental appropriation to cover up the deficiencies under contingent expenses of the same department in the manner itemized hereunder as follows:

Maintenance and repair of dispensary building	P 400.00
Illumination and power	674.00
Maintenance of CHO vehicles	290.00
Office supplies	195.00
Traveling expenses of personnel	46.00
Total	P1,605.00

SECTION 2. This Ordinance shall take effect immediately upon its approval.
