RESOLUTION NO. 65

"The Board, on motion of Councilor Aviles, seconded by the Fleor Leader;

"RESOLVED, to urgently request the City Engineer to make a parceliary survey on the lets of public land not otherwise applied for and/ or claimed behind Barrio Lake Danae with a definition of read right of way as far as Sitio Gaas for the purpose of apportioning said lets for resettlement by the present occurants of certain sections of the barrio falling within the reservation area for Lake Danae National Park, and do, as this Body hereby does, adopt:

ORDINANCE NO. 33

AN ORDINANCE REVERTING THE SUM OF THREE THOUSAND PESOS (\$\frac{1}{2}\$,000.00) FROM OUT OF ITEM NO. 29 OF (\$C_35\$) ORMOC CITY WATERWORKS SYSTEM, 1969—1970 CITY ENDOET, FOR SUPPLEMENTAL APPROPRIATION FOR PARCELIARY SURVEY OF PUBLIC LANDS NOT OTHERWISE APPLIED FOR AND/OR CLAIMED BEHIND BARRIO LAKE DANSO WITH DEFINITION OF ROAD RIGHT OF WAY AS PAR AS SITIO GAAS FOR RESETTLEMENT PURPOSES.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of three thousand peses (\$\mathbb{P}_3,000.00), or so much thereof as may be necessary, is hereby reverted from out of Item No. 29 of (\$\mathbb{C}_{-35}\$) Ornoc City Waterworks System, 1969-1970 City Budget, said sum to be made available as supplemental appropriation for parceliary survey on the lots of public land not otherwise applied for and/or claimed behind Barrio Lake Danae with a definition of road right of way as far as Sitio Gaas in order that these lets will be apportioned to the present occupants of certain sections of the barrio falling within the reservation area for Lake Danae National Park.

SECTION 2. This Ordinance shall take affect immediately upon its approval.
