## RESOLUTION NO. 66

"WHEREAS, the City Health Officer in a communication dated May 29, 1970, has requested the reversion of \$370.00 from out of salary savings in his department to be made available for his travel and transportation in view of a directive of the Honorable City Mayor for him to proceed to either Manila or Cebu immediately to secure anti-typhoid vaccine fer Ormec City;

ORDINANCE NO1 34

AN ORDINANCE REVERTING THE SUM OF THREE HUNDRED SEVENTY PESOS FROM OUT OF SALARY SAVINGS IN THE CITY HEALTH DEPARTMENT FOR SUPPLEMENTAL APPROPRIATION FOR TRAVEL AND TRANSPORTATION OF THE CITY HEALTH OFFICER TO SECURE ANTI-TYPHOID VACCINE IN CEBU OR MANILA

BY IT ORDAINEN, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of three hundred seventy pesos (\$370.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings in the City Health Department, said sum to be made available as supplemental appropriation for travel and transportation of the City Health Officer to secure anti-typhoid vaccine in Cebu or Manila.
