RESOLUTION NO. 67

"WHEREAS, the Honorable Vice-Chairman of the Committee on Health and Public Welfare, Councilor Samson, has recommended the appropriation of ₱440.00 for the printing of posters on the prevention of typhoid fever in coordination with the Ormoc Medical Society's public service of educating our constituents especially in the rural areas on the proper disposal of waste and urine, eradication and control of flies' breeding places, avoiding close contact with cases or suspected cases of typhoid fever, food contamination, safe drinking water, and all other matters relative thereto;

"WHEREAS, this august Body finds the recommendation of Councilor Samson most worthy of our consideration in view of the reported cases of typhoid fever in the northern towns of Tabugon and Borbon, Cebu, which are not so far from the province of Leyte;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by Councilor Porcadilla;

"RESOLVED, to adopt:

ORDINANCE NO. 35-A

AN ORDINANCE APPROPRIATING THE SUM OF FOUR HUNDRED FORTY PESOS (₱440.00) FOR THE PRINTING OF POSTERS ON TYPHOID FEVER PREVENTION.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of four hundred forty pesos (₱440.00), or so much thereof as may be necessary, is hereby appropriated from out of funds not otherwise appropriated in the City Treasury, said sum to be made available as supplemental appropriation for the printing of posters on typhoid fever prevention.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
