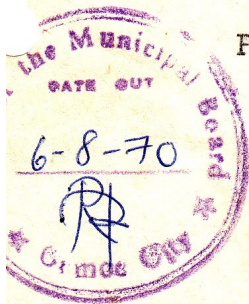
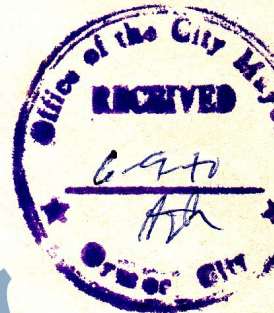
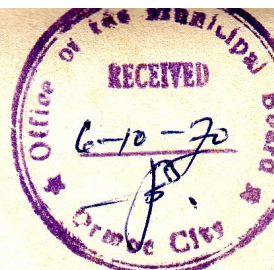

**RESOLUTION NO. 68**

"WHEREAS, the Deputy Chief of Police in a communication dated May 27, 1970, has requested an appropriation of P500.00 for office supplies inasmuch as this item is already exhausted in the current appropriation and that said item is badly needed to accomplish office records in preparation for audit inspection by the Police Commission in the near future;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by Councilors Aviles and Mejia;

"RESOLVED, to approve the request of the Deputy Chief of Police, and do, as this Body hereby does, adopt:

**ORDINANCE NO. 36**

AN ORDINANCE REVERTING THE SUM OF FIVE HUNDRED PESOS (P500.00) FROM OUT OF SAVINGS IN THE POLICE DEPARTMENT FOR SUPPLEMENTAL APPROPRIATION FOR OFFICE SUPPLIES OF THE SAME DEPARTMENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of five hundred pesos (P500.00), or so much thereof as may be necessary, is hereby reverted from out of savings in the Police Department, said sum to be made available as supplemental appropriation for office supplies of the same department.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
