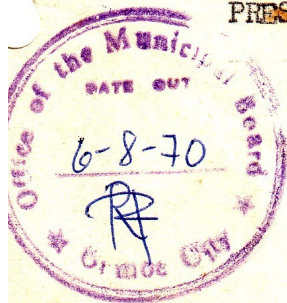
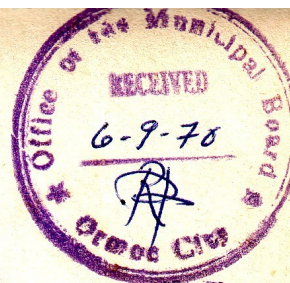

RESOLUTION NO. 69

"WHEREAS, the Chief of Fire Department has made representations with this august Body for the reversion of P223.60 from out of salary savings of his department in order to supplement the original appropriation for uniform allowance which was not sufficient despite various biddings for the purpose;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded jointly by Councilors Aviles and Mejia;

"RESOLVED, to approve the request of the Chief of Fire Department and do, as this Body hereby does, adopt:

ORDINANCE NO. 37

AN ORDINANCE REVERTING THE SUM OF TWO HUNDRED TWENTY-THREE PESOS AND SIXTY CENTAVOS (P223.60) FROM OUT OF SALARY SAVINGS IN THE FIRE DEPARTMENT FOR SUPPLEMENTAL APPROPRIATION FOR UNIFORM ALLOWANCE OF SAID DEPARTMENT

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of two hundred twenty-three pesos and sixty centavos (P223.60), or so much thereof as may be necessary, is hereby reverted from out of salary savings in the Fire Department, said sum to be made available as supplemental appropriation for uniform allowance of the same department.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
