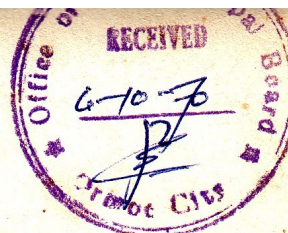
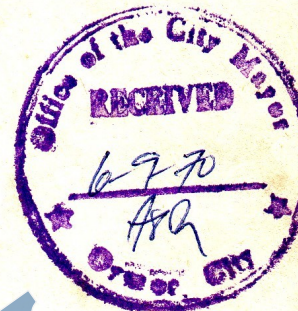


EXCERPT FROM THE MINUTES OF THE REGULAR SESSION OF THE

RESOLUTION NO. 70

"WHEREAS, it has been found out that our appropriation of P550.00 in Resolution No. 20-Ordinance No. 14, current series, is not sufficient to purchase a heavy-duty hanging scale for official use in the public market;

"NOW, THEREFORE, on motion of Councilor Samson, seconded jointly by Councilors Kangleon and the Floor Leader;

"RESOLVED, to amend Resolution No. 20-Ordinance No. 14, current series, and do, as this Body hereby does, adopt:

ORDINANCE NO. 38

AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND TWO HUNDRED FIFTY PESOS (P1,250.00) FROM OUT OF SALARY SAVINGS IN (C-25a) AGRICULTURAL EXTENSION SERVICE TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR THE PURCHASE OF A HEAVY-DUTY HANGING SCALE FOR OFFICIAL USE IN THE PUBLIC MARKET.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one thousand two hundred fifty pesos (P1,250.00), or so much thereof as may be necessary, is hereby reverted from out salary savings in (C-25a) Agricultural Extension Service, said sum to be made available as supplemental appropriation for the purchase of a heavy-duty hanging scale for official use in the public market.

SECTION 2. Ordinance No. 20, current series, is hereby repealed.

SECTION 3. This Ordinance shall take effect immediately upon its approval.
