## RESOLUTION NO. 70

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one thousand two hundred fifty pesos (\$1,250.00), or so much thereof as may be necessary, is hereby reverted from out salary savings in (0-25a) Agricultural Extension Service, said sum to be made a vailable as supplemental appropriation for the purchase of a heavy-duty hanging stale for official use in the public market.
