RESOLUTION NO. 8

"WHEREAS, the Assistant City Treasurer, Mr. Margarito G. Tugonon, who is due for retirement on June 10, 1970, but whose last day of service will be on March 31, 1970, as he will be on leave effective April 1, 1970, preparatory to his retirement, in a communication dated January 13, 1970, has requested an increase of his rate of compensation from \$\mathbb{P}8,400.00 to \$\mathbb{P}9,600.00 per annum effective as of July 1, 1969, inasmuch as it is the general policy of the National Government that when one is retirable he is given one rank higher in salary;

"WHEREAS, this request calls for an amount of \$1,200.00 which can be reverted from out of the item on DBP loan amortization under (C-36) Market and Slaughterhouse, particularly, Item No. 7, page 20 of the 1969-1970 Ormoc City Budget;

"MHEREAS, with the increased rate of compensation of Mr. Tugonon his everage salary for the last three years will also increase a little which becomes the basis of his monthly gratuity and which this august Body believes he is entitled to after years of faithful, honest and diligent service to the Government, especially, the City of Ormoc;

PER ANNUM EFFECTIVE JULY 1, 1969.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one thousand two hundred pesos (\$\mathbb{P}\)1,200.00), or so much thereof as may be necessary, is hereby reverted from out of Item No. 7 of (C-36) Market and Slaughterhouse, page 20, 1969-1970 Ormoc City Budget, said sum to be made available for supplemental appropriation to cover the salary adjustment of Mr. Margarite G. Tugonon, retiring Assistant City Treasurer, from \$\mathbb{P}\\$8,400.00 to \$\mathbb{P}\\$8,600.00 per annum.
