ORDINANCE NO. 41

AN ORDINANCE REVERTING THE SUM OF TWO HUNDRED FIFTY PESOS (P250.00)
FROM OUT OF ITEM NO. 21 OF (C-35) ORMOC CITY WATERWORKS SYSTEM
TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR COMMU-
NICATIONS OF THE SAME DEPARTMENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of two hundred fifty pesos (P250.00), or so
much thereof as may be necessary, is hereby reverted from out of Item
No. 21 of (C-35) Ormoc City Waterworks System, said sum to be made
available as supplemental appropriation for communications of the same
department.

SECTION 2. This Ordinance shall take effect immediately upon its
approval.
