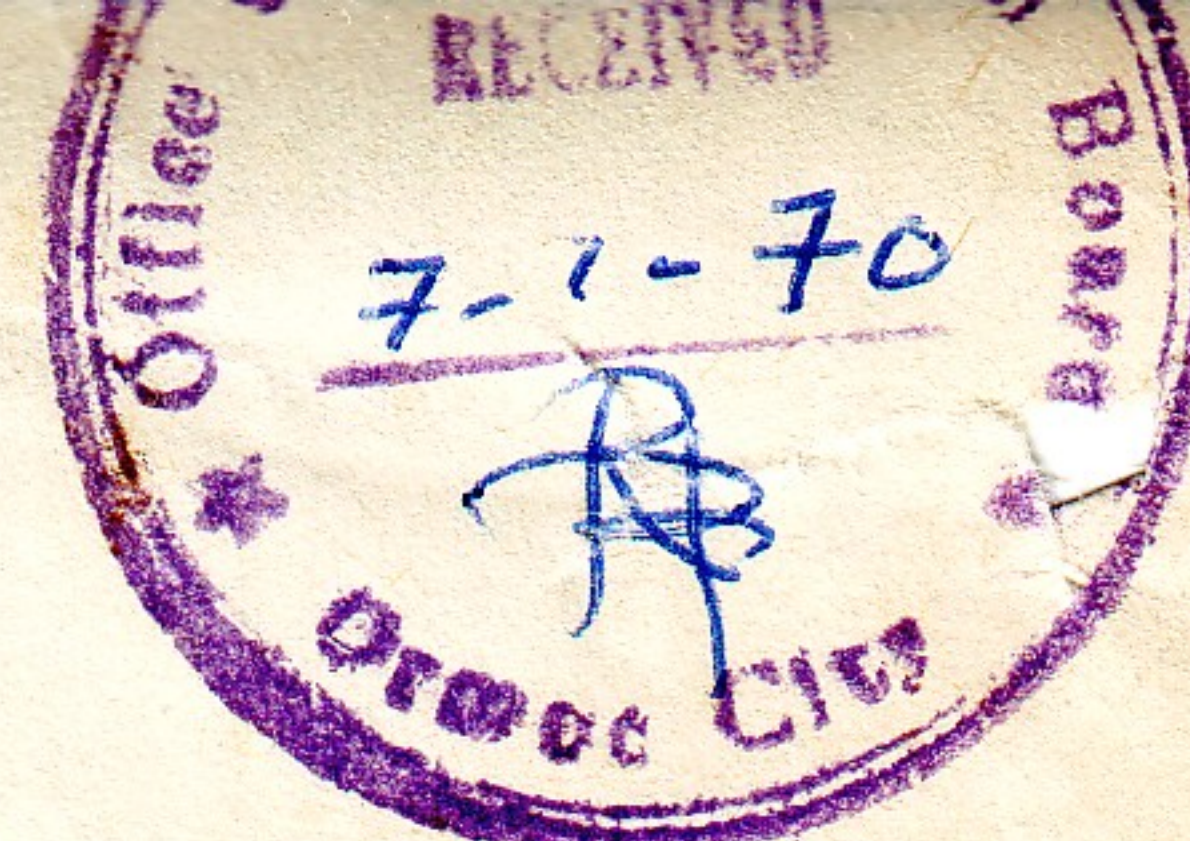


EXCERPT FROM THE MINUTES OF THE REGULAR SESSION OF THE

"RESOLVED, to adopt:

ORDINANCE NO. 42

AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND SIXTY-SIX PESOS AND SIXTY-SIX CENTAVOS (P1,066.66) FROM OUT OF SALARY SAVINGS IN THE LAW DEPARTMENT TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR PAYMENT OF TERMINAL LEAVE OF ATTY. LUCAS M. CASTAÑOS, RESIGNING SPECIAL COUNSEL OF THE SAME DEPARTMENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one thousand sixty-six pesos and sixty-six centavos (P1,066.66), or so much thereof as may be necessary, is hereby reverted from out of salary savings in the Law Department, said sum to be made available as supplemental appropriation for payment of the terminal leave of Atty. Lucas M. Castaños, resigning Special Counsel of the same department.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
