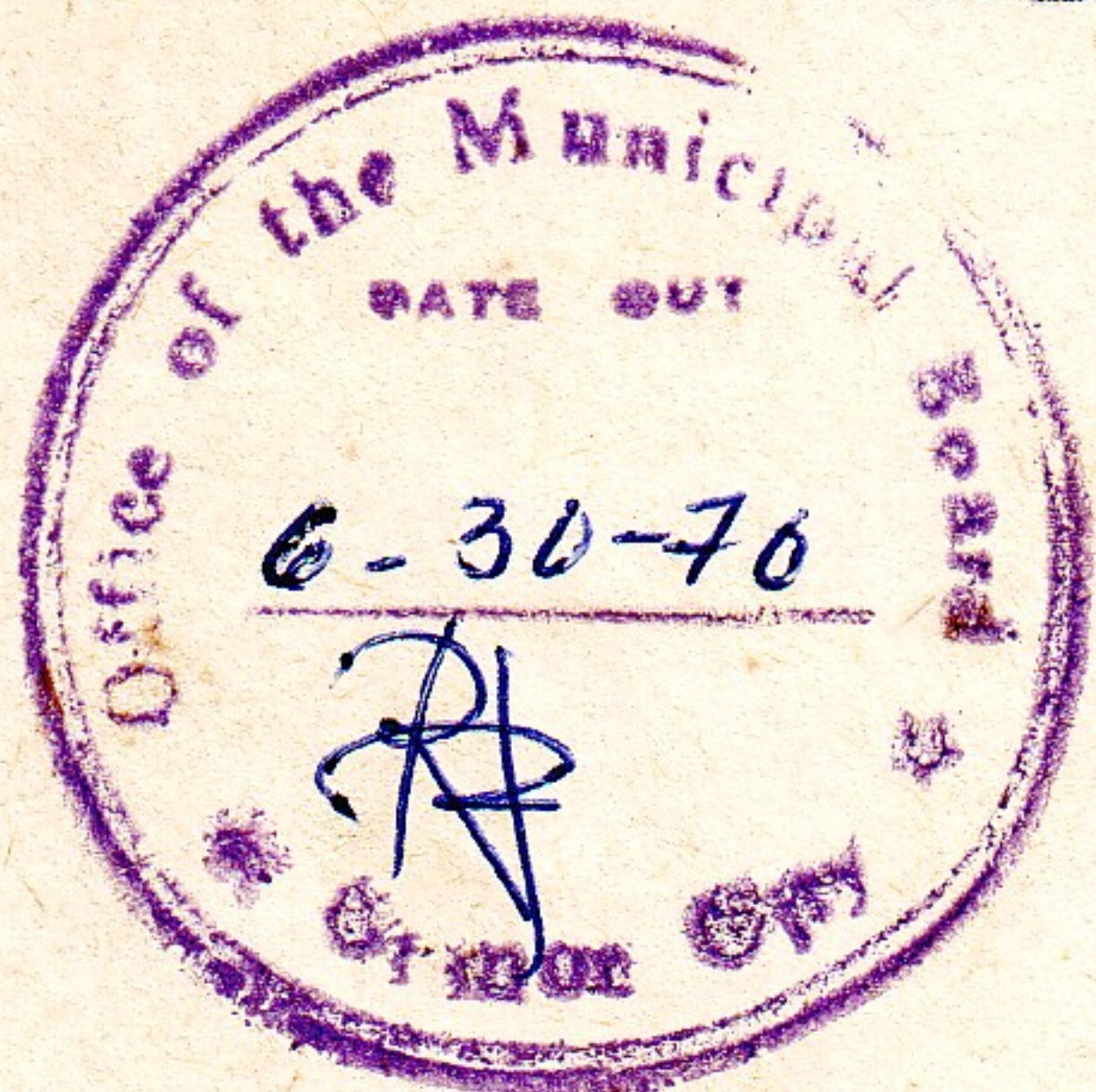

ORDINANCE NO. 43

AN ORDINANCE REVERTING THE SUM OF THIRTY-FIVE PESOS (P35.00) FROM  
OUT OF ITEM NO. 4 OF RESOLUTION NO. 34-ORDINANCE NO. 23, C.S.,  
TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR COMMU-  
NICATIONS IN THE CITY COURT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of thirty-five pesos (P35.00), or so much there-  
of as may be necessary, is hereby reverted from out of Item No. 4 of  
Resolution No. 34-Ordinance No. 23, current series, said sum to be made
