

RESOLUTION NO. 82

"The Board, on motion of Councilor Samson, seconded jointly by Councilors Kangleon, Aviles, and the Floor Leader;

"RESOLVED, to adopt:

ORDINANCE NO. 44

AN ORDINANCE APPROPRIATING THE SUM OF TWO THOUSAND THREE HUNDRED EIGHTY-THREE PESOS AND SEVENTY-EIGHT CENTAVOS (P2,383.78) FROM OUT OF THE SHARES OF ORMOC CITY FROM SWEEPSTAKES DRAWS, SAID SUM TO BE MADE AVAILABLE FOR PURCHASE OF MEDICINES AND IMPROVEMENT OF HEALTH CENTERS IN THE CITY OF ORMOC.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of two thousand three hundred eighty-three pesos and seventy-eight centavos (P2,383.78), or so much thereof as may be necessary, is hereby appropriated from out of the **shares** of Ormoc City from the Philippine Charity Sweepstakes draws, said sum to be made available as supplemental appropriation for the purchase of medicines and improvement of health centers in the City of Ormoc.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, June 24, 1970.
