"RESOLVED, to adopt:

ORDINANCE NO. 45

AN ORDINANCE REVERTING THE SUM OF FIVE HUNDRED PESOS (P500.00) FROM OUT OF SALARY SAVINGS AND UNEXPENDED BALANCE ON REPAIRS IN THE CITY HEALTH DEPARTMENT TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR ~~SUBSISTENCE~~ AID TO "OPERATION TULONGAN"

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of five hundred pesos (P500.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings and unexpended balance on repairs in the City Health Department, said sum to be made available as supplemental appropriation for ~~subsidence~~ aid to "Operation Tulongan".

SECTION 2. This Ordinance shall take effect immediately upon its approval.
