"RESOLVED, to adopt:

ORDINANCE NO. 46

AN ORDINANCE REVERTING THE SUM OF THREE THOUSAND SEVEN HUNDRED TWENTY PESOS (P3,720.00) FROM UNEXPENDED BALANCES IN THE CURRENT FISCAL YEAR'S FUNCTIONAL EXPENSE APPROPRIATIONS TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR TELEPHONE RENTALS OF VARIOUS GOVERNMENT OFFICES OF ORMOC CITY, AS CLAIMED BY THE BUREAU OF TELECOMMUNICATIONS, ORMOC AGENCY.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of three thousand seven hundred twenty pesos (P3,720.00), or so much thereof as may be necessary, is hereby reverted from out of unexpended balances in the current fiscal year's functional expense appropriations, said sum to be made available as supplemental appropriation for telephone rentals of various government offices of Ormoc City, as claimed by the Station Manager, Bureau of Telecommunications, Ormoc Agency.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
